It is understood that the Non refundable booking fee -\$50.00 will not be returned if the booking is cancelled by renter. Rentals will continue during inclement weather (ie rain), but not during unsafe weather (ie lightning).

- If a rental must be cancelled by MOCA staff before it starts due to unsafe weather, the renter may choose to re-book another date upon availability or receive a full refund.
- If a rental has started but must be stopped due to unsafe weather, renter may choose to receive a refund for the portion of rental unused, or book that time for another date.
- Our professional lifeguarding staff on duty at the time of the rental will have the final say if a rental may proceed
- MOCA Pool requires 24 hours cancellation notice in order to be eligible to receive a refund or rebooking

The renter also agrees that any damage to the facilities during the term of their rental will be charged to them or their organization. Cancellation due to inclement weather (authorized by Pool Manger) will rescheduled at no Booking/Deposit fee charge.

The renter further agrees that the Lifeguard on duty may have removed from the premises, any person(s) causing damage or nuisance. The renter agrees to save, indemnify, and hold the Pool/Lifeguard or Millican-Ogden Community Association from any legal liability for bodily injury or property damage arising by, or as a result of the use of the pool. The renter further agrees to waive any right to recovery against the Pool/Lifeguard or Millican-Ogden Community Association for the loss or damage incurred to the renter's property during the term of this agreement.
